Soccer Rules

PLEASE BRING EMPLOYEE / COMPANY I.D.!!

The official Ohio High School soccer rules will be in effect for all games with the following additions:

1. Games will consist of two thirty-minute halves, with five minutes allowed for half-time. The tournament director may shorten halves if needed due to weather conditions or schedule changes. The officials will advise both teams prior to the beginning of the game.
2. **CHANGE- In the event of a tie, a shoot out will determine the winner. Each team must pick five players (3 men & 2 women). Each team will then alternate players kicking on goal. The team may kick in any order. If after the fifth player, there remains a tie, five additional players are picked. You may change your keeper at any point.**
3. Teams must have matching jerseys, preferably ones that are numbered. List your color preference on your roster. Colors will be assigned in order of registrations. Be specific (i.e. medium blue, navy, royal blue or light blue). ***ALL TEAMS MUST HAVE A SECOND COLOR WITH THEM IN THE EVENT TWO TEAMS HAVE SIMILAR JERSEYS.*** A flip of a coin will determine which team changes.
4. Games will not be called because of weather conditions, if at all possible. The tournament director may call any game on day of play if conditions are becoming hazardous. All efforts will be made to insure the safety of all players.
5. All games have two high school rated officials and a five minute grace period to field their team.
6. No slide tackling!!
7. Teams may substitute with possession of ball (on own throw-ins and corner kicks) and on any goal kick. Teams may also substitute on opposing team's-throw in if the opposing team substitutes a player.
8. These are possible breakdowns for the team structure of the Corporate Challenge Soccer Tournament:
 - A) 3 women and 8 men
 - B) 2 women and 7 men
 - C) 1 woman and 6 men

***** If a team loses a woman to a red card, they must also lose a man.***

9. When a player passes the ball back to the goalie to be cleared, the goalie must use his/her feet to clear the ball. The only exceptions will be if a teammate heads the ball back to the goalie.
10. Goalie may not lay the ball down and then pick the ball up again.
11. Any player who is red carded will not only be ineligible to play the remainder of that game, but also the next game.
12. A FORFEIT / SCRATCH results in a victory and a 5 - 0 score for the opposing team.
